Contains an acceptable replacement for 1,1,1-trichloroethane under the EPA snap program. Contains no CFC's, ozone depleting chemicals or petroleum distillates. Features a 36,200 volt dielectric strength, which combined with non-flammability makes SAFETY SOLVENT the only degreaser safe for use on motors, generators, relays and control panels while equipment is in operation. Energized equipment use only. Not to be used for motorized vehicle maintenance, or their parts.

USAGE

Recommended for industrial, commercial, institutional as well as household use. For use on industrial equipment, heating and air conditioning equipment, generators, electric motors, windings and power tools.

Directions for dual spray valve: Press down valve for close up work. Tilt valve forward for hard-to-reach areas and pinpoint flushing action. Jet stream will shoot approximately 8 feet.

DIRECTIONS

SHAKE WELL BEFORE USING. Saturate part to be cleaned. Allow to air dry. For heavily encrusted areas, brush, then rinse off with a second application. Note: May remove some paints. Pre-test in a small area before using. DO NOT USE ON PLASTICS.
